Notice is hereby given that a General Meeting of the governing body of the above-named political subdivision will be held on Thursday, December 4, 2025, beginning at 6:00 P.M., in the conference room of the Duval County Groundwater Conservation. The district office is located at 231 E. Railroad Avenue, Benavides, Texas. Duly posted notice of said meeting.
